Item IV : Additional condition of contractor to be included based of recent guidelines issued by Ministry on 29.10.2021 for both work i.e. (EPC Contractors & Authority Engineer)



The Ministry of Finance, has issued General Instruction on Procurement and Project Management vide order no. F.1/1/2021-PPD dated 29.10.2021; the copy of Order is attached with this email. With reference to clause No 12.5 of this order it was suggested by the Ministry that “ All Project executing authorities implementing work contracts involving aggregate payment of more than Rs 100 crores per annum shall have an online system for monitoring of the bill submitted by contractors. Such a system shall have the facility for contractors to track the status of their bills. It shall be mandatory for all contractors’ bills to be entered into the system with date of submission and date of Payment.”

Additional condition of Tender

1	Additional condition of Tender	Authority Engineer shall be responsible for maintaining an online system for monitoring of the bill submitted by contractors. Such a system shall have the facility for contractors to track the status of their bills. It will be mandatory for contractors to enter the bills into the system with date of submission & date of Payments. This system should have access to Authorities Representatives such as University Administration including the Engineering Unit and Finance Department of the University. The Authority Engineer shall be responsible for providing such facilities to the University. Authority Engineer shall be responsible for verification of bills (including taxation) submitted by contractor in accordance with the provision of contract documents and recommends the University for settlement of the same.
